# WHAT ARE STAMY RIGHTS?

YOU HAVE THE RIGHT TO ...

- be treated with respect and dignity.
- remain silent after you have given your name and address.
- be told why you are being stopped.
- obe told why you are being arrested.
- have your rights explained to
  you and be given a notice of rights on
  arrival at the Garda station.
- ask for your next of kin to be informed that you are in Garda custody.
- ask that your national embassy is informed that you are in Garda custody.
- ask to talk to a lawyer before you are interviewed by the Gardaí and to have the lawyer sit in the interview with you. This will be free if you cannot afford it. You generally have the right to remain silent during the interview.
- ask to be seen by a medical doctor if you feel unwell.
- ask for the help of a sign language interpreter if you are deaf and/or a language interpreter if you are unable to speak or understand the English language well.
- apply to a judge for free legal aid
  (a lawyer to represent you for free),
  if you have been charged with a criminal
  offence and are due to appear in court.

## THE GARDAÍ HAVE POWERS TO:

- Ask you to stop, even while driving. You must always comply with this request. If you are driving, you must stop as soon as it is safe to do so.
- Search you without your consent, but only if a Garda member has a reasonable suspicion that you are involved in or about to be involved in a crime, or you have an unlawful object (e.g., a weapon, illegal drugs or something stolen) in your possession. They must inform you of the specific crime they suspect you are involved in before they search you.
- Arrest you if they suspect you of committing a particular criminal offence. At the time of your arrest, you should be informed of the reason(s) for the arrest and your rights should be explained to you, in a language that you understand.
- Use reasonable force to carry out an arrest. Only the most minimal amount of force can be used to achieve the arrest. You should not resist arrest as you may be charged with an additional offence.
